All dogs entered in NAMASCUSA Sanctioned SCORE Rally Trials require either a NAMASCUSA Registration Number or a NAMASCUSA Tracking Number in order to have their legs tracked and title certificates mailed out. A NAMASCUSA Tracking Number Application is attached to this premium.

PRIZES & AWARDS: Placement rosettes or ribbons will be awarded for 1st through 4th place for Qualifying and non-qualifying scores for all classes. Dogs with an NT (no time) are not eligible for any ribbons. Qualifying ribbons will be awarded to all dogs receiving a qualifying score.

SPECIAL PRIZES & AWARDS: Special awards will be presented to the HIL and HIT Miniature Australian Shepherd. Awards will be based on results from all three trials.

SETUP: Participants may set up Friday AM. Participants must be 10 feet back from the rally ring.

This trial is sanctioned by the North American Miniature Australian Shepherd Club of the USA (NAMASCUSA). Exhibitors through submission of entry acknowledge that they are knowledgeable of SCORE Rally rules and regulations, including but not limited to the following rules regarding entry:

- This trial is open to all dogs being at least six months of age, including purebred and non-purebred, except bitches in season or dogs with disabilities, injuries or illnesses which may cause the dog pain or great discomfort, or dogs exhibiting signs of aggression that threaten the safety of other dogs or humans.
- Safety shall be of foremost consideration in actions and conduct by handlers at all times. It is expressly understood that exhibitors alone are responsible for the behavior of their dog(s) and / or children. Any exhibitor whose dog(s) and / or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the show committee, be asked to leave the show site. In that case, no refund of any fees paid will be made.
- Entry fees will not be refunded in the event that a dog is absent, disqualified, excused, or barred from competition by action of the show committee.
- No entry fee will be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire, an act of God, public emergency, act of a public enemy, or any other cause beyond the control of the organizing committee.
- Exhibitors are responsible for complete, accurate, and legible information on the entry forms: illegible or incomplete entries cannot be entered in the show.
- Owners with disabilities are encouraged to compete. Any necessary modifications to the exercises must be provided by the handler to the judge and approved by the judge.
- Upon successful completion of an exercise, the owner may choose to briefly pet or touch the dog as a reward. The owner may also choose to give the dog food as a reward. Food may NOT be used as a lure to help the dog complete an exercise. Food rewards must be contained in pockets or hidden treat pouches and only be present in the owner's hand in between exercises. Any petting, touching, or feeding that significantly interrupts the flow of performance shall be scored accordingly.
- Exhibitors that plan to use food as a reward in the ring must indicate that on their entry forms. All teams NOT using food shall be scheduled to compete before those teams using food.
- Dogs must remain under control at all times whether on or off leash while on show grounds. Day kenneling only is permitted, unless otherwise posted at the show site. Crates may be left overnight at your own risk.
- Please pick up after your dog and yourself.
- The hosting clubs will not be responsible for the loss or damage to any dog exhibited, or the possessions of any exhibitor whether the result be accident or other cause. It is distinctly understood that every dog at this event is in the care and control of his owner or handler during the entire time the dog is on the show premises.
- There shall be no refunds in the event a dog and/or handler are dismissed from competition, regardless of the reason for such dismissal.
- A 100% refund will be given for any requests for withdrawal received prior to the closing date. After the closing date until 24 hours before the trial, refunds will be given for bitches in heat, injured or ill dogs (with verification from a vet upon request) or family emergency, **less a \$20.00 handling fee.**
- Checks not honored by the bank do not constitute a valid entry fee. There will be a \$25.00 Service charge for bank returned checks.

Tracking Number Application

In order to have the **NAMASCUSA Herding and/or Rally SCORE Programs** track your qualifying legs and titles your dog needs to either be registered with NAMASCUSA or have a NAMASCUSA Tracking Number.

If your dog is currently registered with NAMASCUSA, you do NOT need a tracking number, use your registration number on the entry form. If your dog is not registered with NAMASCUSA you will need to apply for a tracking number if you want your legs tracked. Complete a separate NAMASCUSA Tracking Number Application for each dog you are registering. Please print clearly—this information will appear on all tracking records.

There is a one time registration fee of \$5.00 to apply for a NAMASCUSA Tracking Number. Please make checks out to NAMASCUSA. Send payment with application to the address below **OR** you may submit the application with your herding entry form to the trial secretary. If submitting to the trial secretary please make sure to include the registration fee.

Registration confirmation will be emailed to you. If you do not have email, it will be sent via US mail. Please allow 2-4 weeks for processing.

Note: You only need ONE tracking number to compete in all NAMASCUSA performance venues.
